

Italian Law D.Lgs 196/2003

According to article 13 D.Lgs. 30/06/2003 n. 196 (Personal Data Protection Act) we inform that the collecting and processing of personal data is aimed to carry on the activities of Rohlig Italia, such as freight forwarding, custom clearing, warehousing, collection and delivery of goods, and all the connected services, as well as to comply with the local fiscal and administrative regulations, and to promote and sell their services in Italy and abroad, and for evaluate customer satisfaction concerning the quality of the service offered.

Rohlig Italia S.p.A. is responsible for the data processing, which takes place in their branches in Milano, Bologna, Verona and Torino, both on hard copies and with electronic means according to the security regulations specified by the Privacy Act and the purpose of the processing. The personal data can be transferred to other organizations that are part of the Rohlig Group as well as to their overseas agents.

The data can be processed and visualized by all Rohlig staff, specifically trained and in charge of such activity.

The communication of your data to Rohlig is mandatory to carry on the services that they offer to their clients if not otherwise indicated. If Rohlig collects other types of data for marketing or sales campaigns, and evaluate customer satisfaction concerning the quality of the service offered, a specific authorization shall be asked to the owner of those data.

Rohlig Italia S.p.A. grant to the owner of the personal data the rights specified in Art. 7 of the Personal Data Protection Act, such as the right to have access their own data, the right to ask and obtain corrections, amendments and the deletion of the data if they are obsolete, wrong, or collected illegally.
